CASE 01

CASE 02

After a dinner party, Diane found a deep scratch on her car's front-left fender. Five cars were parked single-file in a narrow driveway: Yvonne (deepest), Hank, Diane, Carter, and Brooke (closest to street). The scratch appeared sometime during the party. Case file HARD-008.

Q Whose car scratched Diane's?

1. The scratch on Diane's car is on the front-left fender, consistent with a sideswipe from a car on her left side.
2. The driveway is single-lane. Cars parked in order: Yvonne, Hank, Diane, Carter, Brooke (street-side).
3. Nobody left during the party. But Brooke moved her car to let a delivery truck pass at 7:30 PM.
4. Brooke's car has a fresh scrape on its rear-right bumper. The paint residue matches Diane's car color.
5. Hank's car shows no damage. Yvonne's car was deeper in the driveway and couldn't have reached Diane's front.
6. Carter's car is parked behind Diane (between Diane and Brooke). No damage on Carter's vehicle.
7. The delivery truck driver says Brooke backed up quickly to make space.

CASE 03

A confidential research document was secretly modified at 11:47 PM. The edit came from Workstation C in the east wing. Four researchers had building access that night: Gabrielle, Victor, Simone, and Raj. Case file HARD-009.

Q Who modified the document?

1. The edit was made from Workstation C in the east wing at exactly 11:47 PM.
2. Door access logs: Gabrielle badged into the east wing at 11:30 PM and left at 12:05 AM.
3. Victor's key card shows he accessed only the west-wing lab after 10 PM.
4. Simone's exit was logged at 10:15 PM. She did not re-enter the building.
5. Raj was in his north-wing office on a phone call from 11:30 PM to 12:15 AM. Phone records confirm the call.
6. The east wing requires a separate badge access. No tailgating is possible – the door has a mantrap.
7. Gabrielle's research area is in the west wing. She had no stated reason to be in the east wing that night.

Q Who stole the laptop?

1. Only attendees of the 9 AM meeting knew the laptop was in locker 47. Ross did not attend the meeting.
2. Meeting attendees: Oliver, Tanya, Min, and Jade.
3. The locker was picked (no damage, no master key used). This requires skill with a lock pick set.
4. Oliver worked as a locksmith for six years before joining the company.
5. Tanya, Min, and Jade have no known lock-picking experience.
6. Hallway camera shows Oliver on the second floor at 1:15 PM. He says he was 'walking to the vending machine.'
7. A lock pick set was found in Oliver's desk drawer during a subsequent search.

- Wei was in Singapore for a business trip the entire week. Passport stamps and hotel receipts confirm this.
- The check was printed on Mr. Harmon's personal check printer, which is kept in his locked office.
- Ingrid has a spare key to Mr. Harmon's office.
- Carl has significant personal debt, but he's right-handed and doesn't have office access.
- Ingrid's fingerprints were found on the check printer, though she says she 'cleans it occasionally.'

 - ☒ Parking order: Yvonne (arrived first, parked deepest), then Hank, then Diane, then Carter, then Brooke (last, closest to street).

- ☒ The document was edited at 11:47 PM from Workstation C in the east wing.
 - ☒ Door logs: Gabrielle entered the east wing at 11:30 PM and left at 12:05 AM.

- ☒ The laptop was in locker 47. Only people at the 9 AM meeting knew this number.
 - ☒ Meeting attendees: Oliver, Tanya, Min, and Jade.

- ☒ The forged check had a left-handed signature (pen strokes analyzed by the bank).
 - ☒ Of the five suspects: only Ingrid and Wei are left-handed.
